# **POSITION**

on the Fair Play Committee of the ESPORTS ASSOCIATION OF CROATIA





#### 1. GENERAL PROVISIONS

- 1.1. The Committee for Fair Play of the ESPORTS ASSOCIATION OF CROATIA (hereinafter referred to as the Committee) is an independent permanent working body of the ESPORTS ASSOCIATION OF CROATIA.
- 1.2. The Committee's activities are determined by this Rulebook, the Charter of the ESPORTS ASSOCIATION OF CROATIA and the decisions of the administrative bodies of the ESPORTS ASSOCIATION OF CROATIA.
- 1.3. The Committee acknowledges the legal goals and objectives of the ESPORTS ASSOCIATION OF CROATIA for the promotion and improvement of fair play and the values it represents in esports and undertakes to fulfill the duties assigned to it by these Regulations.
- 1.4. Official name: "Fair Play Committee of the ESPORTS ASSOCIATION OF CROATIA".

## 2. PURPOSE OF THE BOARD

- 2.1. The main purpose of the Committee is to promote and develop fair play and the values it represents in esports, training and everyday life, respecting the rules of respect for opponents, fighting against violence, doping, etc.
- 2.2. The committee was also established for the purpose of suppressing offenses defined by the regulatory legal acts of the ESPORTS ASSOCIATION OF CROATIA; carries out, in its full scope, systematic monitoring of compliance with the legislation and regulations of the ESPORTS ASSOCIATION OF CROATIA related to the organization and holding of sports competitions within the framework of esports leagues accredited by the ESPORTS ASSOCIATION OF CROATIA, as well as the implementation of activities accredited by the ESPORTS ASSOCIATION OF CROATIA, as well as implementation of activities to prevent violations affecting the results of these competitions; to verify the facts of violations of the fair play rules and draw appropriate conclusions, etc.

# 3. TASKS OF THE COMMITTEE

- 3.1. Implements modern organizational measures and improves fair play initiatives in esports leagues accredited by the ESPORTS ASSOCIATION OF CROATIA.
- 3.2. It cooperates with the media, state bodies and local self-government bodies in order to promote and spread the principles of fair play.
- 3,3. Leads the method of judging and observing the uniformity of intergretations of episodes of the game in accordance with the requirements of the current Regulations for tournaments and the rules of the game.



- 3.4. He represents the common position of the ESPORTS ASSOCIATION OF CROATIA in non-governmental and state organizations that deal with issues of fair play in esports and moral issues.
- 3.5. Organizes seminars and other relevant events to promote fair play and ethics.
- 3.6. Monitors sports competitions within the framework of esports leagues accredited by the ESPORTS ASSOCIATION OF CROATIA, ensures timely consideration of appeals, statements of facts affecting the results of such sports competitions, cases of violations of the provisions of the Fair Play Rules, conducts appropriate checks of these facts and statements.

## 4. BOARD COMPOSITION AND WORK ORGANIZATION

- 4.1. The board consists of a president and two members. Committee members cannot be members of any esports league and other esports organizations.
- 4.2. The President of the ESPORTS ASSOCIATION OF CROATIA approves the President of the Committee, as well as the members of the Committee based on the proposal of the Committee President.
- 4.3. The composition of the Committee is appointed for an indefinite period. The Chairman and members of the Board may be dismissed from the Board at their own request or by decision of the ESPORTS ASSOCIATION OF CROATIA President.
- 4.4. The President or any member of the Board has the right to submit a request for resignation to the President of the ESPORTS ASSOCIATION OF CROATIA of his own free will or decision. Until such a decision is made, the president/member of the Commission who submitted the request continues to perform his duties.
- 4.5. In cases where the president/member of the Committee who has submitted a request for resignation actually avoids, without valid reasons, the performance of his duties until the decision on the termination of his powers is made, the president of the ESPORTS ASSOCIATION OF CROATIA by order appoints a temporary president/member of the Committee in the capacity of president/member of the Committee until on the day when the president of the ESPORTS ASSOCIATION OF CROATIA makes the appropriate decision on the dismissal of the president/member of the Board.
- 4.6. The Committee organizes its work in accordance with the plan approved by the Chairman of the Committee.





# 5. POWERS AND DUTIES OF THE BOARD

- 5.1. The committee monitors the quality of work of referees and players during competitions of esports leagues accredited by the ESPORTS ASSOCIATION OF CROATIA.
- 5.2.the facts of violations by the ESPORTS ASSOCIATION OF CROATIA referees and ESPORTS players of accredited ESPORTS leagues of legal, regulatory norms, rules and regulations.
- 5.3. Performs rating certification of the ESPORTS ASSOCIATION OF CROATIA and players of esports leagues accredited by the ESPORTS ASSOCIATION OF CROATIA.
- 5.4. Rotates judges according to rating indicators.
- 5.5. Accepts the appeal of natural or legal persons (hereinafter referred to as the applicant) on the analysis of controversial issues related to the rules and principles of fair play in esports league matches accredited by the ESPORTS ASSOCIATION OF CROATIA via e-mail address.
- 5.6. Based on the analysis of fair play, prepares a conclusion on the presence or absence of facts influencing the results of sports competitions of esports leagues accredited by the ESPORTS ASSOCIATION OF CROATIA and/or facts of violation of the provisions of the Fair Play Rules, conveys recommendations for decision-making.
- 5.7. The final decision on the fair play analysis is delivered to the applicant to the email address to which the appeal was sent within 30 calendar days from the date of the appeal to the Committee.
- 5.8. The committee has the right to cooperate with the media on issues of fair play and ethics in esports.

# 6. POWERS AND DUTIES OF THE PRESIDENT OF THE BOARD

- 6.1. He personally supervises the work of the board and manages its meetings
- 6.2. Distribution and approval of functional responsibilities of Board members.
- 6.3. Submits proposals for changes in the composition of the Committee to the president of the ESPORTS ASSOCIATION OF CROATIA for approval.
- 6.4. Decides on the holding of Board meetings.
- 6.5. Proposes the agenda of the Board sessions.
- 6.6. Makes permanent committees of the Board and approves their personal Composition.
- 6.7.represented by the Committee for Relations with Other Working the ESPORTS ASSOCIATION OF CROATIA Members.



- 6.8. He signs the documents of the Committee.
- 6.9. Organizes inspections of applications, complaints and reports on the impact on the results of sports competitions and/or violations of the Fair Play Rules.

#### 7. BOARD SESSION

- 7.1. The meeting of the Committee is considered competent for decision-making, provided that more than half of the members of the Committee are present.
- 7.2. The preparation of materials for discussion on the issues received by the Committee is carried out by one of its members on behalf of the Chairman of the Committee.
- 7.3. In the process of considering the issue, the Committee may resort to consultations and conclusions of experts, respecting the principles of impartiality and confidentiality.
- 7.4. Each member of the Committee has one vote.
- 7.5. At the session, all members of the Committee vote in person.
- 7.6. The decision is made by a simple majority of votes on the number of members of the Committee present by open voting.
- 7.7. With an equal number of votes, the chairman's vote at the meeting is decisive.
- 7.8. The Board can meet and make decisions via Internet video conferencing, which allows all Board members present at the same time to be heard and seen.
- 7.9. Decisions made at Committee meetings are formalized in the Protocol, which is signed by the Chairman of the Committee and all present members of the Committee, and to which the materials used are attached.

# 8. COMMITTEES OF THE BOARD

- 8.1. The establishment of permanent committees and the approval of their personal composition is carried out by the Chairman of the Committee.
- 8.2. Standing committees are working bodies of the Committee that perform functional duties in accordance with the areas of work.
- 8.3. Standing committees consist of: committee chairman, committee deputy chairman and committee members in the amount determined by the Committee.
- 8.4. The Board approves regulatory documents on the organization of the the Board and standing committees.



## 9. FINAL PROVISIONS

- 9.1. This Regulation enters into force with the approval of the President of the ESPORTS ASSOCIATION OF CROATIA.
- 9.2. The Committee's activities are financed from the ESPORTS ASSOCIATION OF CROATIA.
- 9.3. All other issues that are not provided for in these Regulations are resolved by the president of the ESPORTS ASSOCIATION OF CROATIA.
- 9.4. Amendments and additions to these Regulations are considered and approved by the president of the ESPORTS ASSOCIATION OF CROATIA on the proposal of the president of the Committee.
- 9.5. The activity of the Committee can be suspended by the decision of the president of the ESPORTS ASSOCIATION OF CROATIA.
